

# DG's New Year's Message



As we begin 2012 and enter our 21st year of operations since Belize Ship Registry (International Merchant Marine Registry of Belize, IMMARBEL) celebrated its 20th anniversary of operations at the end of last year, we will continue to improve our technical performance with the expected return of IMMARBEL in the QualShip 21 status this year as we

have recorded no detention during these past three years and we are confident to make progress in both Paris and Tokyo MOUs. And although we are still in the Paris MOU grey list, we have considerably reduced the number of detentions in all other MOUs.

Maintaining the quality of IMMARBEL fleet is our major goal. We have managed to clean up its image reducing significantly over the last years the number of vessels non-compliant with international regulations thanks to the implementation of strict policy rules concerning age limitations, intense monitoring campaigns to ensure detention ratios, disciplinary measures such as fines, cancellations of vessels because of their poor performance in Port State Controls, constant audit performed on Recognized Organizations (ROs) and ships operators and an increased presence of safety inspectors worldwide which currently total 186. As you will see in the pages of this Newsletter, we have developed and will continue to promote an

aggressive marketing strategy to inform ship owners of the Middle East, Europe and Asia of the advantage of the Belize flag and incite them to register in IMMARBEL. The approval of the 'New Merchant Ships Registration Act' has made our fleet more attractive and competitive to ship owners, law firms and bankers offering mortgages to our vessels and is already boosting the registration of newly built vessels. In addition we have opened new markets and increase our representation in many countries, with the designation of several deputy registrars.

IMMARBEL has also implemented a control and monitoring system for its fishing fleet, which represents nearly 10% of its total fleet of ships, comparable to any major flag administration in the world. In coordination with Belize Fisheries Department, IMMARBEL participates actively in all main regional organizations, SPRFMO, IOTC, IATTC, ICCAT, and WCPFC. Because of that constant surveillance in the past ten years, Belize is highly regarded as a serious and compliant Registry determined to fight illegal fishing activities which only serve to undermine conservation measures in the world's oceans. As it has been doing for more than ten years, IMMARBEL will again participate at POSIDONIA, in Athens, Greece, in June 4-8 this year where you can find us at booth no. 3324.

The Registry will also participate for the first time in SHIPTECH, Dalian, China, a major exhibition-conference, at the end of October. This event that takes place in Dalian World Center brings ship owners of China and all neighboring countries, is highly praised for the quality of its exhibition as it brings together the largest number of companies involved in the shipping sector.

Registry. He was accompanied in the panel by speakers: Sean Bond, director Environmental solutions-ABS, Hari Krishna, Associate, Clyde & Co Middle East Region, Mohamed Sherine El Nagggar, A.K. Nagggar Group, Ms Alice Vaidyan, Dep Mgr, General Insurance Corporation of India.

His presentation on ship registration was excellent, with pictures and graphics, motivating numerous questions from the attendees. His focus on IMMARBE was Belize is a small but quality register, very personalized, customer friendly and recognized by its immediate response to customers' queries.

“IMMARBE has [assured by the publication of the New Act Legislation] the confidence of international lending institutions as a flag state, which is the ship owner's first consideration when it comes to register his mortgages and vessels”, explained Juan Felipe Pitty. Belize is expected to achieve QualityShip 21 status in 2012 and has a large commercial fleet in international waters. Dr. Juan David Morgan Jr attended the conference and with Juan Felipe Pitty and both were invited to the Middle East Award Ceremony which was a real show of Middle East personalities and top Middle East shipping businessmen and an excellent networking opportunity.
